The driveway color must conform to a color in the ARC approved driveway stain color palette. Driveways must be prepared according to the directions below. Driveway must be properly maintained with no chipping, bubbling, or peeling.

Stamped concrete driveways may not be painted a solid color. An appropriate sealer must be used to restore the original colors.

Pavers may not be painted a solid color but must be cleaned and sealed according to the manufacturer's directions.

Please read the following and be advised that Staining/Sealing your driveway is a very involved process and must be completed properly to bond to the concrete surface.

SURFACE PREPARATION IS CRITICAL.

+ All oil, grease spots and stains must be removed with a commercial or industrial cleaner or degreaser.

+ Bare concrete requires a commercial/industrial etching solution as part of the preparation.

If your concrete surface is not prepared properly the concrete stain/sealer that you apply will not adhere and will bubble and peel. If this happens the normal Compliance procedure will be followed.
