ARC Reminders

- 1. ARC request forms can be found on the Westminster community website. These must be sent to or dropped off at the manager's office no later than the Friday before the scheduled ARC meeting. ARC meets one time per month on the second Wednesday of each month.
- 2. No work can be started before the ARC approves your request!
- 3. If you live in Governors Run I, Governor's Run II or the Fairloop Villas you must first get your form signed by your neighborhood association, before you submit your request to the office.
- 4. Samples are required for new roofs, new mulch or flower bed cover, and new pavers. These can also be dropped off at the office. Approval will not be granted without these samples.
- 5. Please remember to pick up your samples after your request has been approved.

A Note from Compliance

Compliance will be following up on the Design Review Guidelines which state:

Compressors and fans for central air conditioning or heat pump systems which are located outside the exterior of the building shall be adequately landscaped with <u>natural landscaping that maintains</u> its green year round to prevent being viewed from any street

Some Notes from the Board Meeting

- 1.NO Fireworks are allowed in the community
- 2. New pygmy palms have been planted along Oxford Ridge. Check them out!
- 3. New pavers will be installed in August at the front gate. The pavers will be more conducive to high traffic with a much better base installed.

Some Notes from Irrigation Committee

The Irrigation committee will be working on a program to assign watering times to residences by address in an effort to even out the irrigation demand on the pumps.

Watering restrictions and regulations are controlled by Lee County Ordinances. See some of the restrictions below.

Lee County Water Restrictions When Can I Water?

Address

Odd numbers ending in 1,3,5,7,9 may water on Wednesdays and or Saturdays <u>one time each day</u> between midnight and 9 am OR 5 pm to midnight

Even numbers ending in 0,2,4,6,8, may water on Thursdays and or Saturdays one time each day between midnight and 9 am OR 5 pm to midnight.

No irrigation is allowed from 9 am to 5 pm or any time on Mondays, Tuesdays, or Fridays.

Lee County Water Restrictions Continued

How Do I Report a Watering Violation?

Residents of unincorporated Lee County should call Natural Resources at (239)533-8109.

Watering Restriction Exceptions

Installation of new lawns and landscaping. Irrigation is limited to areas of new landscaping only. An entire irrigation zone may be run if at least 50% of the landscaping is new in that area. If less than 50% only the new plantings may be watered.

Day of Install of new Plantings

Soil irrigation is allowed immediately prior to planting. New plantings and soil may be irrigated once

Days 1-30 after Install

New plantings may be watered on Monday, Tuesday, Wednesday, Thursday, Saturday and/or Sunday only before 9 am and after 5 pm.

Days 31-60 after Install

New plantings may be watered on Monday, Wednesday, Thursday, and Saturday only before 9 am and after 5 pm.

Lee County Sheriff Safety and Security Tip How to Detect a Phony Census Worker

Did you know the U.S. Constitution requires the federal government to take a count of America's population every ten years through a series of questions known as the decennial census? During this time, you can expect criminals to pose as census workers intent on stealing your personal and financial information.

As the U.S. Census Bureau prepares for the mobilization of the 2020 Census, Lee County Sheriff Carmine Marceno encourages you to be on the lookout for phishing emails, door-to-door imposters, and phony phone calls. You can expect to be asked questions about your age, ancestry, health insurance, home value and even fertility; however, the Census Bureau will never ask for:

Your full Social Security number

Money or donations

Anything on behalf of a political party

Your full bank or credit card account numbers

Your mother's maiden name

If someone purporting to be a Census Bureau Representative contacts you and you would like to verify the authenticity of the call, email or home visit, you can reach the Census Bureau's Contact Center at 1-800-523-3205 or the Atlanta Regional Office at 1-800-424-6974.

For additional information on how to identify a legitimate census employee, visit www.census.gov. To report a suspicious email or phone call you may contact the Sheriff's Office Fraud Line at 239-258-3292. To report a suspicious person going door-to-door without proper identification, call the Lee County Sheriff's Office at 477-1000.
