Westminster Community Geothermal

The Board of Directors is asking Community Members to approve the expenditure of up to \$50,000.00 for the construction and installation of a Symbiont geothermal system to heat (or cool) the Community swimming pool and spa. This system will replace the current propane heaters and uses the natural heat from two drilled wells to heat the pool and spa.

The funding for this system will come from the "Capital Fund for Community Amenity". No special assessments or revenue from the monthly HOA assessments will be used for this project.

The proposal from Symbiont Service Corporation notes the following benefits:

Like propane gas, the system is unaffected by outdoor air temperature or sunshine

Costs approximately 74% less to operate than propane gas

Pays for itself in less than three years

Has a 15 to 20 year serviceable life expectancy, with savings of \$295,000.00 during its life (present propane heaters have a 3 to 5 year life expectancy)

Is environmentally friendly, as opposed to the exhaust from burning propane gas

Geothermal Continued

All well water used in the process is returned underground in a closed loop system

Can be reversed to cool the pool during hot summer months

Has the best warranty in the industry – five years parts and labor (in 2017 Westminster spent \$12,000.00 in repair expenses on the heaters)

First year's maintenance contract is included in the price; after that, only \$500.00 per year

These benefits have been confirmed by interviews with existing customers (references attached)

The Westminster Declaration, Section 8.3, requires two-thirds approval of the Members present (in person or by proxy) and voting at a duly noticed membership meeting for material alterations of/or substantial additions to the Common Areas of Westminster costing more than \$40,000.00 during any fiscal year.

Terra Siesta Community (Ellington FL) - Pool larger than ours, 86 degree water temp, \$18,000.00 per year savings over propane heat resulting in a 2.5 year payback, \$200.00 in repairs over 5 years. Strongly supports thermal heating as it is so environmentally friendly.

2100 Condominium Association (Palm Beach FL) - 81,000 gallon pool, 86 degree water temp, 5 year pay back, very environmentally friendly, uses cooling feature during hot spells, only downfall is that they are located directly on the Atlantic Ocean and on cold 40 degree blustery days the system can only maintain 80 degree water temps. Recommends that we proceed with Symbiont.

Cypress Grove at Wildcat Run (Estero FL) - 28,000 gallon pool, 86 degree water temp, 1250 gallon spa kept at 103 degrees, installed in March of 2006, so unclear about numbers but insisted that they have saved considerable amount of money since installation, reported that the heat recovery time does slow down during cold spells but is able to maintain desired temperatures, very minor repairs over the life of the system, is able to turn system off in summer months to further save money. "We are very happy with the system".

Riva Del Lago Condominiums (Ft. Myers FL) - 60,000 gallon pool, 88 degree water temp, two spas 1000 gallons kept at 103, 18 month payback including the fact that they limited their propane system to 82 degree maximum temp, runs system from October until two weeks after Easter. "Installation of this system is a no-brainer".

FGCU (Ft. Myers) - several installations with multiple systems, has saved a lot of money, very happy with Symbiont Services, recommends that we install the system.

Community Shred Event Returns

Are you concerned about identity thieves stealing your personal information? One way to avoid becoming a victim of this growing crime is to dispose of your personal documents by shredding items that contain your name, address, social security number, and other important data.

To help keep your identity safe, the Lee County Sheriff's Office, in cooperation with the Pilot Club of Fort Myers, is once again hosting a community wide shred event scheduled to take place on Saturday, March 10th between 10:00am-1:00pm in the northwest corner parking lot of the Miromar Outlets, located at 10801 Corkscrew Road in Estero. . A secure, on-site shredding truck will safely destroy your personally identifying information under the watchful eye of law enforcement volunteers. Participants should remove all non-paper items, such as clips, staples, binders, etc. in advance, with no commercial shredding, please. A donation of \$5 per box to benefit the Sheriff's Office Project Lifesaver Program will be collected.

If you do not know what to shred, here are a list of documents we feel are shred worthy:

Bank statements, ATM receipts, canceled or voided checks

Expired driver's licenses, identification cards, all picture ID's

Expired credit cards, credit card bills, carbon copies, summaries and receipts

Documents containing maiden names, addresses, phone numbers, email addresses, pin numbers, passwords and investment information.

Medical and dental records [] Pre-approved credit card applications

Credit scores, leases, contracts, utility bills and letters containing signatures

Pay stubs, resumes

Tax forms

Report cards

Travel itineraries, airplane ticket stubs, luggage tags
